## Aims

 Points (ECPs) nominated by the Member and Partner States and confirmed by the ESPON Monitoring Committee;

• Carrying out of specific transnational project activities bringing together the members of the ECP network in targeted and innovative outreach activities.

## Lessons learnt

- Ways of involving policy makers at the transnational scale should be pursued
- The issues of scale should be stronger considered in the transnational capitalisation of ESPON
- The language used by ESPON should be simplified in order to make the reports, publications and the website more readable and accessible for the stakeholders.
- Use of social media should be further strengthened taking into account that they target quite different types of users.
- To reach a wider audience, events and workshops organised by the ESPON Programme could benefit from a wider geographic touch-down.
- ESPON should consider cooperating more closely with the Structural Funds Programmes, such as URBACT and INTERREG, in order to further strengthen the capitalisation of ESPON results, methods and tools.





## **Example – ESPON on the ROAD**

- The extensive transnational capitalisation activities carried out by the ECP network brought together 30 national partner institutions and more than 200 individuals.
- The diversity of the ECP network is also expressed in the fact that 13 of the participating institutions were public authorities while 17 were academic institutions.



 Besides the transnational networking activities, the ECPs also contributed to a wider dissemination of ESPON at national and sub-national level by producing publications and arranging workshops on their own initiative and reaching out to national, regional and in some cases even local stakeholders in their national language.
