EU Negotiations

on the Regulations for Cohesion Policy and the Multiannual Financial Framework for 2021-2027.

Start of negotiations: **October 2018**

Cohesion legislation into force: **1st July 2021.**

- **Socio-economic analysis (2019)**
analysis strengths, weaknesses, opportunities and threats by consulting the various cross-border and national institutions in the Greater Region. A consultation on the thematic priorities for the Greater Region was also launched.
- **Programming Committee**, working group begin discussions on the intervention logic for the programme (definition of priorities 2020).
- **Programming Committee** approves first draft of the cooperation programme for the strategic environmental assessment (2021).
- **Submission** of the Interreg Greater Region Programme to the European Commission: March 2022.
