2. OVERVIEW OF THE IMPLEMENTATION OF THE COOPERATION PROGRAMME (ARTICLE 50(2) OF REGULATION (EU) NO 1303/2013 AND ARTICLE 14(3)(A) OF REGULATION (EU) NO 1299/2013)

Key information on the implementation of the cooperation programme for the year concerned, including on financial instruments, with relation to the financial and indicator data.

The year 2016 was the first full year of implementation of the ESPON Cooperation Programme and it has been a rather challenging year. From a management point of view, the consolidation of the Management and Control System (with the finalisation of the e-MS system), the audit for the designation of the programme authorities (started in July and ended at the end of year), the first Annual Implementation Report together with the implementation of the other programme duties towards the EC (with first declaration of expenditure from the Single Beneficiary in April and October).

At the same time it was the first year of implementation of the Single Operation. While the setting up of the EGTC supporting infrastructure and internal administrative procedures was progressively achieved the implementation of the activities defined in the first Annual Work Plan could be smoothly kicked off. In terms of implementing the content of the programme under P1 by the Single Beneficiary, first steps were taken to support relevant policy processes. To ensure that the content is taken up by potential users for evidence the deliveries have been organised in a way that the outputs can contribute to and support policy processes in a timely way. Also, the engagement of stakeholders from the early stages of the implementation of activities was ensured to encourage the ultimate uptake at the level of the potential users of the results.

The first 7 applied research projects were launched and inception deliveries received and positively accessed ensuring the production of high-quality pan-European territorial evidence by the involvement of the project Support teams. For example, the inner peripheries and European Territorial Futures activities are expected to contribute to the debate on the EU Territorial Agenda post-2020. The activities on employment dynamics, SMEs, inner peripheries and FDI flows are expected to feed the debate on Cohesion Policy post-2020.

The first Targeted Analyses have also been launched and the analytical results shall be used by the stakeholders who submitted the proposals in their policy-making processes. Approved activities reflects a wider European perspective and the results could be taken also by other stakeholders to inspire regional policies and strategies in their territories. In general, the 6 targeted analysis activities selected in the course of 2016 have already reached a sufficiently wide thematic and considerable geographical coverage. Thematically, they cover topics such as regional and functional urban governance, integrated territorial planning, migration and refugees, territorial scenarios for 2050. Geographically the selected stakeholder cover 21 countries across the ESPON space.

Seven Policy Briefs on key policy relevant issues were published in response to policy demand from targeted stakeholders and key high-level policy processes, synthesising key territorial trends and closely coordinated with outreach activities. For example, the policy brief on Urban Partnership Themes in a Wider Territorial Context showed examples of European-wide territorial evidence that can be used and further developed to support the work of 4 pilot partnerships. The brief on polycentric territorial structures and territorial cooperation supported the discussion between Member States and EU

institutions during the Slovak Presidency on the potential for more polycentric development in Europe by developing territorial cooperation culture and structures and promoting accessibility. The key messages of this policy brief will be further used as inputs for discussion and development of EU Territorial Agenda and European Territorial Reference Framework until 2050.

Additional activities were launched under SO3 in particular the Database Portal, the Mapkits, the Data and Map Updates (notably to update dates related to Accessibility by Sea, Road, Rail, Air and Multimodal) and the upgrade of the ESPON TIA Tool.

In relation to the implementation of the outreach and capitalisation five European outreach events were organised including three seminars in association with EU presidencies and two workshops related to key policy processes. At these events ESPON has been engaging with over 650 targeted stakeholders, raising awareness of ESPON evidence being produced and support tools available and gathering feedback on activities for the coming year. Seminars play a key role in the implementation of Priority 1 as they represent the strategic tool to reach out these target groups.

In addition one workshop and one seminar were organised at European level and the first step for engagement at transnational level was taken with the award of the three-year contract on the transnational outreach support. In particular a workshop on Polycentric Territorial Structures and Territorial Cooperation was organised at the Permanent Representation of the Slovak Republic to the EU. A range of high-level policy and academic stakeholders were invited to attend the workshop. A draft working paper Polycentric Territorial Structures and Territorial Cooperation – a key policy priority of the Slovak Presidency - was tabled for discussion at the workshop and the feedback received was taken into account in the development of the Policy Brief. The outcome of the intergovernmental debate on the subject will be used in the following years in the upcoming debate on a potential European Territorial Reference Framework and the next EU Territorial Agenda. The ESPON Seminar “Where are European cities heading? Evidence for better policy-making” was organised, in association with the Slovakian Government, in Bratislava on the 7-8 December. The thematic focus of the seminar was the current policy process around the EU Urban Agenda as an important framework for developing and implementing better policies and providing better knowledge to tackle urban challenges. Targeted and timely territorial evidence to support the work of urban partnerships is one of the key preconditions for their success. The seminar promoted the use of existing and new upcoming ESPON territorial evidence in policy-making by bringing together and facilitating the dialogue among key stakeholders. The debate also raised awareness of ESPON support and helped to increase the potential usefulness of ESPON outputs by engaging stakeholders in designing the content of upcoming activities.

Close attention has been put during this year of implementation to ensure correspondence of activities with policy demand with outputs correctly timed to policy processes in order to promote the use of territorial evidence in policy practice. This approach will be further improved with a more strategically orientated approach to be applied for the preparation of future activities.

3. IMPLEMENTATION OF THE PRIORITY AXIS

3.1 Overview of the implementation

A key focus of the Single Beneficiary was, therefore, to set up the supporting infrastructure and internal administrative procedures that would allow it. As soon as this has been substantially achieved the first activities were kicked-off. Given the new institutional setup of the ESPON EGTC and new public procurement procedures for activities, together with the arrival of a significant number of new staff members, time for learning was needed and some delays occurred throughout the year. However, this process is now completed and the Single Beneficiary can fully focus its efforts towards the implementation of activities.</p> <p>In order to ensure continuity with the considerable progress made during the ESPON 2013 programme and to build momentum in achieving the Single Operation's overall objective is to deliver high-quality territorial evidence to policy development processes. It was also considered important to ensure continuous visibility of ESPON territorial evidence towards key target groups and give high priority to outreach activities from the outset.</p> <p>All of the key activities foreseen for the first year of implementation have been started. Given that implementation of the Single Operation is in the early phase and activities are not yet completed, no result indicator data is currently available.</p>

4. SYNTHESIS OF THE EVALUATIONS

As the CP is based on one thematic priority implemented by the Single Beneficiary, it is obvious that the MA relies on the information delivered by the Single Beneficiary for the implementation of the evaluation plan and its reporting to the EC. The programme evaluation plan foresees that the Single Beneficiary shall provide yearly a report including the following elements:

- An introduction outlining the rationale, background, coverage and main approach to the Evaluation Report.
- A detailed review of evaluation activities undertaken during the preceding year and methods used to capture data (e.g. surveys, questionnaires, number of respondents etc.) taken together with those of earlier years.
- The results of the evaluation activities vis-à-vis the baseline set in the ESPON 2020 CP and the cumulative progress towards achieving the targets set.
- A commentary on the results of the evaluation process and progress towards achieving targets together with recommendations for future evaluation activities (including any recommended changes to programme management).

Taking into account that the Single Operation has been in full operation for less than one year and that no new results from applied research project have yet been produced, it was considered too early to formally evaluate the results of the Single Operation. As a consequence no evaluation reports have been produced and provided by the Single Beneficiary to the MA yet. However, in anticipation of first research outputs becoming available during 2017, the ESPON EGTC launched a restricted procurement procedure to purchase technical advice on an Evaluation and Monitoring Methodology. The purpose of this service is to ensure that the ESPON EGTC has a proper strategy in place to fulfil all ESPON 2020 Programme and EU evaluation and monitoring requirements. It is expected that with this support a full Evaluation and Monitoring Strategy for all results and output indicators will be in place by the second Quarter of 2017.

Notwithstanding the above, the ESPON EGTC continues to undertake continuous internal evaluation, including assessment of feedback from stakeholders, of the performance of the Single Operation and as to whether progress made towards targets is sufficient.

Beyond the considerations regarding the Priority 1 of the implemented by Single Operation and in the context of the ongoing evaluation implemented by the Managing Authority with the Monitoring Committee as already reported in section 3.1 two processes were discussed and revised in order to improve the implementation of the programme.

The first process is related to the nomination and involvement of Project Support Teams and the revisions led to ensure that at least an MC members is part of each PST in order to provide a follow-up on the implementation of the activities to the MC. The second process revised is related to the dialogue between the MC and the Single Beneficiary for the elaboration of the Annual Work Plan for the following year. An earlier and more strategic set up has been decided in order to allow for the agreement on a strategic framework that should better guide the Single Beneficiary towards the selection of the

concrete activities to be implemented according to the policy strategic objectives set for the year to come.

5. ISSUES AFFECTING THE PERFORMANCE OF THE PROGRAMME AND MEASURES TAKEN

(a) Issues which affect the performance of the programme and the measures taken

In the context of Priority 1, given the new institutional setup of the ESPON EGTC and new public procurement procedures for activities, together with the arrival of a significant number of new staff members, a time for learning and training had to be taken into account and some delays occurred throughout the year in relation to the timing of the activities foreseen. These early stage operational problems have now largely been recognised, addressed and mostly overcome and additional major issues have adversely affected the performance of the Single Operation.

In relation to the activities foreseen under P1 the Single Beneficiary encountered delays in succeeding to close a contract based on procurement for external services related to the Scientific Quality Management of the applied research deliveries. The procurements was run twice unsuccessfully. The same happened in relation to the Database portal which procurement had to be run twice having some impacts and on the foreseen coordination of the applied research and the database project. (In 2017 the Single Beneficiary took the necessary actions to overcome the situation).

Progress is considered to be on track to achieve targets in relation to the output targets and this on both priorities. In particular, under SO1 the first 7 Applied Research activities have been launched and inception deliveries received. In relation to Targeted Analysis Projects during more than 20 proposals were received of which 6 were selected. In relation to policy briefs 3 Policy Briefs/Thematic Papers were produced, bringing the total to 7 published. Each of the Policy Briefs/Thematic Papers was timed to influence key policy processes in order to maximise impact and widely disseminated at events. Under S04 the few events organised registered the participation of over 650 participants. It is not yet known as to what extent publications are used by targeted stakeholders in policy processes. However, it was already considered important to further broaden the range of attendees at future ESPON events beyond those already familiar with ESPON activities. This shall be achieved with the roll-out of the Outreach Strategy and the Transnational Outreach Project in tandem with the increasing availability of research outputs. An Evaluation and Monitoring Methodology will be put in place in parallel with the roll-out of these activities to provide more fine-grain analyses of attendees at events, their perceptions and the use of publications in policy processes.

Since no evaluation have been implemented due to the early stage of implementation of the programme, no measurement of the progress towards the achievement of the results indicators are available yet.

The implementation of the Single Operation during the first year can be considered satisfactory and progressive improvements were noticed. The delay with the implementation of the activities, due to the time that was needed to set up internal procedure and complete the recruitment of the staff, has been partially catch-up. Additional efforts will be made by the Single Beneficiary in relation to the implementation of the outreach strategy towards the concrete use and uptake of the results as soon as they will become available. The revised process towards the elaboration of the Annual Work Plan, in particular in relation to the agreement of a strategic framework with the MC prior the identification of concrete activities, will considerably improve the consistency and synergies among the different activities implemented. The year 2017 will be crucial to test whether the efforts made in this context will pay off and be visible in the results indicators.

In financial terms, the programme has already committed 100% of the funds. The Single Operation is slightly delayed with its forecast payments and the MA is closely following up the situation in order to take the necessary measures to prevent any de-commitment of funds. The designation procedure that will be notified to the EC in the first months of 2017 will allow to start with the certification of expenditure during the second half of the year.

In relation to the Technical Assistance the revised implementation framework has allowed the reduction of the administrative burden at least in relation to the implementation of the activities financed under P1 under the Single Operation, which are now contracted as service contract. The e-monitoring system has been completed and close coordination has been established between the MA and the Single Beneficiary allowing for a smooth implementation of the Single Operation.

In the context of the ongoing evaluation implemented by the Managing Authority with the Monitoring Committee a revision of the process foreseen for the dialogue between the MC and the Single Beneficiary finalised to find an agreement on main activities to be included in the Annual Work Plan has been implemented. The dialogue between the MC and the Single Beneficiary will start earlier than in the previous experience and will first focus on the main strategic framework for the implementation of the activities for the year to come, instead of focusing on the themes for the applied research projects

only. By this, the MA and the MC intends to link the choice of the specific activities and themes to more strategic policy considerations that should lead to an easier uptake and use of the results by policy maker. This revise process will be used for the dialogue on the Annual Work Plan for 2018.

In general the implementation of the Technical Assistance is processing without problems. The steering of the Single Operation that is done in cooperation with the MC is at the core of the 4 meeting that are held every year and that results in deep strategic debate around the activities to be implemented and their potential concrete use in the policy process with concrete constructive and strategic inputs from all actors involved. In relation to the financial and administrative follow-up of the implementation of the Single Operation, due to the proximity a close cooperation and support has been established between the MA staff and the staff of the Single Beneficiary. This close cooperation is believed to be the key for the anticipation of any problems that could jeopardise the implementation of the ESPON programme.

The particular implementing framework of the ESPON Cooperation and its vocation to support and serve the policy process results in a continuous involvement in its implementation of its main stakeholders.

In particular, as already underlined in the previous sections, the representative of all Member and Partner states involved in the programme are closely associated and involved in the strategic preparation of the Annual Work Plan of the Single Operation that is implementing Priority 1. Their contribution support the Single Beneficiary with the identification of the key policy process for which useful territorial evidence can be provided by the ESPON programme to its key policy actors. At the same time, the Single Beneficiary, both in the preparation of the Annual Work Plan and in its implementation, undertakes regular informal and more structured consultation of key stakeholders at EU level such several EU DGs, Committee of the Regions, European Environmental Agency, CEMR (local and regional authorities), CPMR (maritime and peripheral regions), Euromontana (Mountain areas), AEBC and MOT (cross-border cooperation), Eurocities (urban), Metrex (metropolitan regions), RED (rural areas), EUKN (urban knowledge), Purple (peri-urban areas), and MA and secretariats Interreg Programmes.

In addition, consultations have been implemented at national level by the different participating countries. For example, in Austria the members of the national committee on territorial development and spatial planning in the Austrian Conference on Spatial Planning (ÖROK) – composed by representatives of the federal ministries, the federal regions/*Länder*, the associations of towns and municipalities and social partner organisations - have regularly been informed and consulted about the ESPON activities. In the Czech Republic the National committee for transnational and interregional programmes 2014- 2020 that meets twice a week and in which relevant national partners are represented and can voice their positions on strategic matters concerning the implementation of the programme. A similar structure with the same objective is also existing in other countries, such as Italy and Luxembourg among others.

No additional specific actions have been implemented in 2016, however it is foreseen to have a new Public Consultation in 2017 in the context of the external evaluation of the programme.

10.1 Progress in implementation of the evaluation plan and the follow-up given to the findings of evaluations

As the CP is based on one thematic priority implemented by the Single Beneficiary, it is obvious that the MA relies on the information delivered by the Single Beneficiary for the implementation of the evaluation plan and its reporting to the EC. The programme evaluation plan foresees that the Single Beneficiary shall provide yearly a report including the following elements:

- An introduction outlining the rationale, background, coverage and main approach to the Evaluation Report.
- A detailed review of evaluation activities undertaken during the preceding year and methods used to capture data (e.g. surveys, questionnaires, number of respondents etc.) taken together with those of earlier years.
- The results of the evaluation activities vis-à-vis the baseline set in the ESPON 2020 CP and the cumulative progress towards achieving the targets set.
- A commentary on the results of the evaluation process and progress towards achieving targets together with recommendations for future evaluation activities (including any recommended changes to programme management).

Taking into account that the Single Operation has been in full operation for less than one year and that no results are available from applied research projects, it was considered too early to formally evaluate the results of the Single Operation. As a consequence no evaluation reports have been produced and provided by the Single Beneficiary to the MA yet. However, in anticipation of research outputs becoming available during 2017, the ESPON EGTC launched a restricted procurement procedure to purchase technical advice on an Evaluation and Monitoring Methodology. The purpose of this service is to ensure that the ESPON EGTC has a proper strategy in place to fulfil all MA and EU evaluation and monitoring requirements. It is expected that with this support a full Evaluation and Monitoring Strategy for all results and output indicators will be in place by the second Quarter of 2017.

Notwithstanding the above, the ESPON EGTC continues to undertake continuous internal evaluation, including assessment of feedback from stakeholders, of the performance of the Single Operation and as to whether progress made towards targets is sufficient.

In the context of the ongoing evaluation implemented by the Managing Authority with the Monitoring Committee and as already reported in section 3.1 two processes were discussed and revised in order to improve the implementation of the programme. The first process is related to the nomination and involvement of Project Support Teams and the revisions led to ensure that at least an MC members is part of each PST in order to provide a follow-up on the implementation of the activities to the MC. The second process revised is related to the dialogue between the MC and the Single Beneficiary for the elaboration of the Annual Work Plan for the following year. An earlier and more strategic set up has been decided in order to allow for the agreement on a strategic

framework that should better guide the Single Beneficiary towards the selection of the concrete activities to be implemented according to the policy strategic objectives set for the year to come.

10.2 The results of the information and publicity measures of the Funds carried out under the communication strategy

In the framework of the communication strategy, limited activities are foreseen under the technical assistance, as the main dissemination of results is done by the Single Beneficiary in the framework of the Single Operation financed under Priority 1. The communication activities that have been directly implemented by the MA are the following:

- an web-based information activity presenting the main achievement of the ESPON 2020 Programme. The information took the form of a direct electronic mailing towards the main target groups of the ESPON 2020 cooperation programme. The mailing included information on progresses related to the policy support of the programme in relation to EU Cohesion Policy.
- the MA web portal has been further developed and the information has been updated in order to include the latest information related to the programme implementation and the implementation of the Single Operation. The pages are provided in English and French.
- the EU flag was display at the premises of the MA.

It was foreseen to develop in 2016 a short leaflet with information on the ESPON 2020 Programme and the available opportunities targeting the general public. The leaflet has been elaborated in 2016 but its production has been postponed to the first months of 2017.

In addition to the information activities towards the general public and the stakeholders of the programmes a series of information measures towards the Single Beneficiary were also implemented in relation to:

- the reporting requirements, reporting forms and use of the e-MS reporting tool (for the staff of the Single Beneficiary);
- the first level financial control: scope, implementation and use of the e-MS tools (for the designated first level controller of the Single Beneficiary);
- risk assessment and anti-fraud measures (for selected staff of the Single Beneficiary).
