Decision notes

Welcome by the Chair (Poland)

The chair and the MA both welcomed the participants. The new members of the MC were introduced, and the quorum was confirmed by the MA.

Sessions with the ESPON EGTC

1. Agreement on the Agenda

The MC agreed on the Agenda, no additional points were added.

2. Presentation of the Targeted Analysis RURAPLAN (by Prof. Ulla Higdem, Inland Norway University, the service provider, with the EGTC)

The outcomes of the RURAPLAN targeted analysis were brought forward to the MC meeting. The EGTC introduced the project, informing about its policy uptake potential for the planning in shrinking regions.

3. General Management Provisions for the ESPON 2030 Programme

1. Update on the participation of candidate countries (information)

The MA informed the MC that since the last meeting there was no significant change in relation to the involvement of the candidate countries in the ESPON 2030 Programme.

- **4. Single Operation: implementation status** (highlights based on the MC Info Note discussion):
 - 1. Overall progress: global performance figures, the stock of activities (MC Info Note, ppt and discussion)
 - 2. Management risks (MC Info Note, ppt and discussion)

In conjunction with the distributed MC Info Note no. 8, the EGTC presented the overall progress of the Single Operation, involving the global performance figures, the stock of completed and ongoing activities, as well as activities in scoping or procurement. Further, the EGTC shared the management risks in pursuing the Single Operation targets, in launching activities (potential delays), in implementing Partnership Agreements between the EGTC and the ECPs; and related to staff changes.

Next, the EGTC communicated on capitalisation opportunities from the latest research findings. A number of knowledge development events were held by the EGTC and by the ECPs, while several projects are reaching the stage of completion – allowing for translating evidence to specific policy contexts.

Finally, the EGTC reiterated on steps taken to further streamline and simplify internal communication, also with due regard to the guidance offered by the voluntary MC members from DK and RO after the last MC meeting.

- **5. Further implementation of the Single Operation** (documents and discussion)
 - 1. Information on new evidence production activities (scoping note/s, ppt and discussion)
 - 2. Upcoming knowledge development events (arranged by ESPON EGTC and ECPs) (ppt and discussion)
 - 3. Update on the nomination and contracting of ESPON Contact Points, including the status of ECP work plans (ppt and discussion)
 - 4. Timetable on interaction with the MC (ppt and discussion)

In connection with the distributed MC Info Note No. 8, the EGTC shared insights into the upcoming developments, including the work on new proposals for evidence production activities (also in reference to the new cohesion policy priorities stemming from the mid-term review communication), upcoming events, and further interaction with the MC on promoting new ESPON participation opportunities. Also, the situation with the designation of ESPON Contact Points and absorption rate of funding for national knowledge development activities was presented.

- Overview of the TAP Purpose and policy use; Target groups and peers
- Current portfolio
- Aim and expected outcome of the breakout sessions.

Following the overview of each respective TAP by the TAP coordinators from the EGTC, the MA opened the floor for MC reaction. No questions or comments were raised.

Part II: Plenum: Presentation on the conclusions all 4 TAP (discussion and common conclusions)

The TAP coordinators presented the discussion highlights, informing that – together with key points of discussion – the conclusions will be stored in the updated TAP info-packs.

The MA invited the MC members to discuss the results of the workshops and share additional comments.

7. Developments in Territorial Cohesion, Urban Policy and Cohesion policy including Presidency programmes relevant for the ESPON 2030 Programme presentation by PL, DK, CY Presidencies and inputs from EC (Q&A)

PL, DK and CY presented the highlights of their respective Presidency semesters.

IRL indicated that the location and thematic focus of the Irish presidency will be discussed at the MC meeting in September.

The European Commission (EC) noted that the Multiannual Financial Framework (MFF) will be released on 16 July, with additional regulation expected in November. Following the consultation on Interreg Post-2027 with Interreg programmes, a report is now available on the interreg.eu website.

The MA indicated that the Joint Working Group to define the next ESPON Programme could be set up in November.

8. Timetable MC/MA and EGTC (two documents, one by the MA on 2030, one by the EGTC on SO (see point 10, third bullet) and decision on the MC timetable)

The MA presented the questionnaire on the ECPs that is part of the evaluation of the ESPON 2030 Programme. The questionnaire addresses the nomination process, the funding availability and the framework for the implementation of the activities. The MC were asked to submit comments during the meeting or later, in writing, by the 11th of July. The answers will be analysed by the MA, shared with the evaluators and presented at the MC meeting in November.

4. Audit of the Single Operation (information)

The MA informed that the first audit of the Single Operation was carried out successfully and that no irregularities with financial impacts have been detected.

No other points were raised and the MA closed the meeting thanking the participants for the fruitful meeting and the Polish Presidency for their support and organisation.
